Dear Ms Ainsworth

I write concerning the application by SIMEC Mining (on behalf of Tahmoor Coal Pty Ltd) in May 2022 for the Department's approval of an Extraction Plan for proposed Longwalls S1A - S6A at the Tahmoor Mine.

The Department has given careful consideration to this application. This has included consulting with affected agencies and seeking the advice of the Independent Advisory Panel on Underground Mining (the Panel). The Panel provided the Department with detailed advice in August 2022. This advice contained a large number of recommendations, conclusions and other positions concerning the Extraction Plan, and in particular its Trigger Action Response Plans (TARPs).

I note that SIMEC Mining has significantly revised and expanded the coverage of the TARPs in addressing the Panel's recommendations and other advice and also in consequence to a series of requests made by the Department as a result of its own reviews of the TARPs. The Department now considers the TARPs and the revised Extraction Plan adequate. It therefore gives its approval to Version 2 of the Extraction Plan (dated 9 September 2022), including the key component plans and Version 2.3 of the 23 TARPs that comprise part of that Extraction Plan.

The Department grants this approval subject to the following condition:

That SIMEC Mining must adhere to and implement all time-based and chainage-based commitments set out in Attachment C to its letter to the Department dated 19 September 2022.

The Department has attached a copy of Attachment C for convenience. A copy of this letter will be placed on the Department's Major Project Register, under post approval documents for Tahmoor Mine.
