7. Committee Members Reports				
7.1. Col Mitchell – no update or issues raised but commented there is community concern around what it is happening with Tahmoor Mine.		NOTE		06/03/25
7.2. Nicole Pearce asked the following questions: <ul style="list-style-type: none">If anything happens with the mine, is there money set aside for damage to houses from subsidence? AB confirmed yes, claims for compensation damage would continue to be managed in accordance with the <i>Coal Mine Subsidence Compensation Act 2017</i> controlled by Subsidence Advisory NSW. Mining companies are required to pay yearly levies into a fund managed by Subsidence Advisory NSW. Levy amounts are based on coal extraction rates. Any subsidence-related compensation to home owners would be paid by Subsidence Advisory NSW via the fund ensuring security to residents, irrespective of the mine company financial status.Is there money set aside for rehabilitation? AB confirmed yes, there is also a rehabilitation security deposit held by the Resources Regulator for Tahmoor Coal (as is required of all title holders), that ensures adequate funds are available to complete rehabilitation and subsidence repairs.Are the train workers getting paid by the mines? PV advised alternate work is found for them and they are reassigned. Tahmoor only has a maximum of 4 trains per day (generally only 2 trains per day).Is the water for the wildlife in the Wirrimbirra bushland still being provided? AB confirmed the water trough remains in place with a gravity fed water source.		NOTE		06/03/25
7.3. Karen Moss asked the following questions: <ul style="list-style-type: none">When roadworks are being conducted (eg. Remembrance Dr gas main works), can a 'End of Roadworks' sign be installed so drivers know when the speed limit returns to normal? AB advised we will take this feedback onboard and remind the contractors of this when future works are conducted.When will Remembrance Dr road patch repairs be properly repaired in front of the petrol station? AB advised there will likely be some residual subsidence from longwalls S4A and S5A so the final repair works won't occur until subsidence from these longwalls has settled, likely around mid-late 2026.Could a map be provided with the 20mm subsidence zone for longwall S7A? AB confirmed a map can be provided with the meeting minutes and will provide printed versions for KM. There is also a mine plan with the 20mm subsidence zone included in the monthly community newsletter.How long has the non-disclosure (Deed of Release) been in place? AB advised the requirement to sign a Deed of Release to settle a compensation claim has been in place since Subsidence Advisory NSW implemented the <i>Coal Mine Subsidence Compensation Act</i> in 2017. We recommend the committee contact Subsidence Advisory NSW directly if there are specific issues or concerns with the claim settlement requirements. <ul style="list-style-type: none">There is a rumour that someone had a 6-bedroom house and the mine built them a 3-bedroom house about 6 or 7 years ago. AB advised that the mine does not rebuild homes, and this would need to be referred to Subsidence Advisory NSW for clarification. The legislation states that compensation is provided on a 'like for like' basis so we do not believe this rumour to be true. CM confirmed he was also asked about the same rumour six months ago and advised the resident that it was just a rumour and there is no truth to it.

8. Mining Operations Update – Mine Update (presented by Peter Vale)				
8.1. Mine Update: <ul style="list-style-type: none">Longwall S3A was completed and sealed late December 2024.Most of the longwall equipment was relocated to Longwall S4A. Installation of equipment will be completed when funds become available.Development mining was halted during December 2024 due to lack of supplies to support production.The mine has progressively reduced operations since early December 2024. In February 2025, the workforce were advised that no further work was possible, and they were to remain at home on standby, on full pay.Tahmoor Coking Coal sits within Liberty Primary Metals Australia Pty Ltd group (LPMA) and does not form part of One Steel Manufacturing Pty Ltd, which owns and operates the Whyalla Steelworks and iron ore mines in the Middleback Ranges in South Australia. The announcement by the South Australian government to put One Steel Manufacturing into administration does not directly impact Tahmoor Coking Coal.The GFG Alliance, which owns Tahmoor Coking Coal previously announced its intention to sell part or all of its equity in Tahmoor Mine. This is no longer the main focus of the GFG Alliance and they are in the final stages of securing external funding which will ensure Tahmoor can restart operations within the coming weeks. This funding will allow Tahmoor to repay suppliers and secure equipment needed to restart the mine. Until this time, the workforce will remain at home on standby.Part of the workforce returned to site today to restart the coal handling preparation plant (the washery), with approximately 100,000 tonnes of ROM coal ready to be washed ahead of its sale. The sale of this coal will assist with our revenue stream restart.		NOTE		06/03/25

<ul style="list-style-type: none">It has been an uncertain time for the mine and we understand the concerns in the community with Tahmoor being a large employer for the local area. We have received feedback from some of the local businesses in Bargo and Tahmoor that they are suffering due to the workforce remaining at home and not visiting the local establishments (eg. for petrol, coffee, shopping, etc.).<ul style="list-style-type: none">WS asked about the external funding being sourced, does that mean GFG sold the mine? PV advised that prior to the South Australian government announcing that they were putting One Steel Manufacturing into administration, GFG announced publicly that they were going to sell Tahmoor Coal Mine or part of the mine to assist with funds for the Whyalla Steelworks. That necessity to assist that side of the business does not exist anymore and GFG have shifted their focus to securing funding from an external creditor for Tahmoor specifically which we will pay back over time.KM asked if the royalties been paid? PV advised no, that is part of the debt owed (approximately 4 months of royalties). Tahmoor has been working with NSW government and met with the Resources Minister twice in the last few weeks to discuss the status of the mine and restart plans in place. We have committed to making good on our payments to the NSW government within a period of time.WS asked if there are any concerns with restarting the mine after being shut down since December and a lot of machinery standing still? PV advised the main focus was keeping our people paid and on standby, so they are ready to go when we are in a position to restart. Underground was shut down in a planned manner that left us in a good position for an efficient restart.MM asked if ventilation and water pumps are still operating? PV confirmed yes these are operating and there is still around 20% of our workforce coming to work to keep the underground environment safe and compliant.DH asked if the Water Treatment Plant was still operating? PV confirmed yes.Tahmoor is aiming to fully restart sometime in April but this is subject to funding being delivered.Investigations into carbon emission reduction strategies ongoing, with focus on Ventilation Air Management (VAM) as well as conversion of extracted gas to electricity.Coal price in the last 3 months has been slowly declining as supply exceeds demand. Steel prices have been suppressed, resulting in lower prices for associated commodities, including coal. <p>8.2. 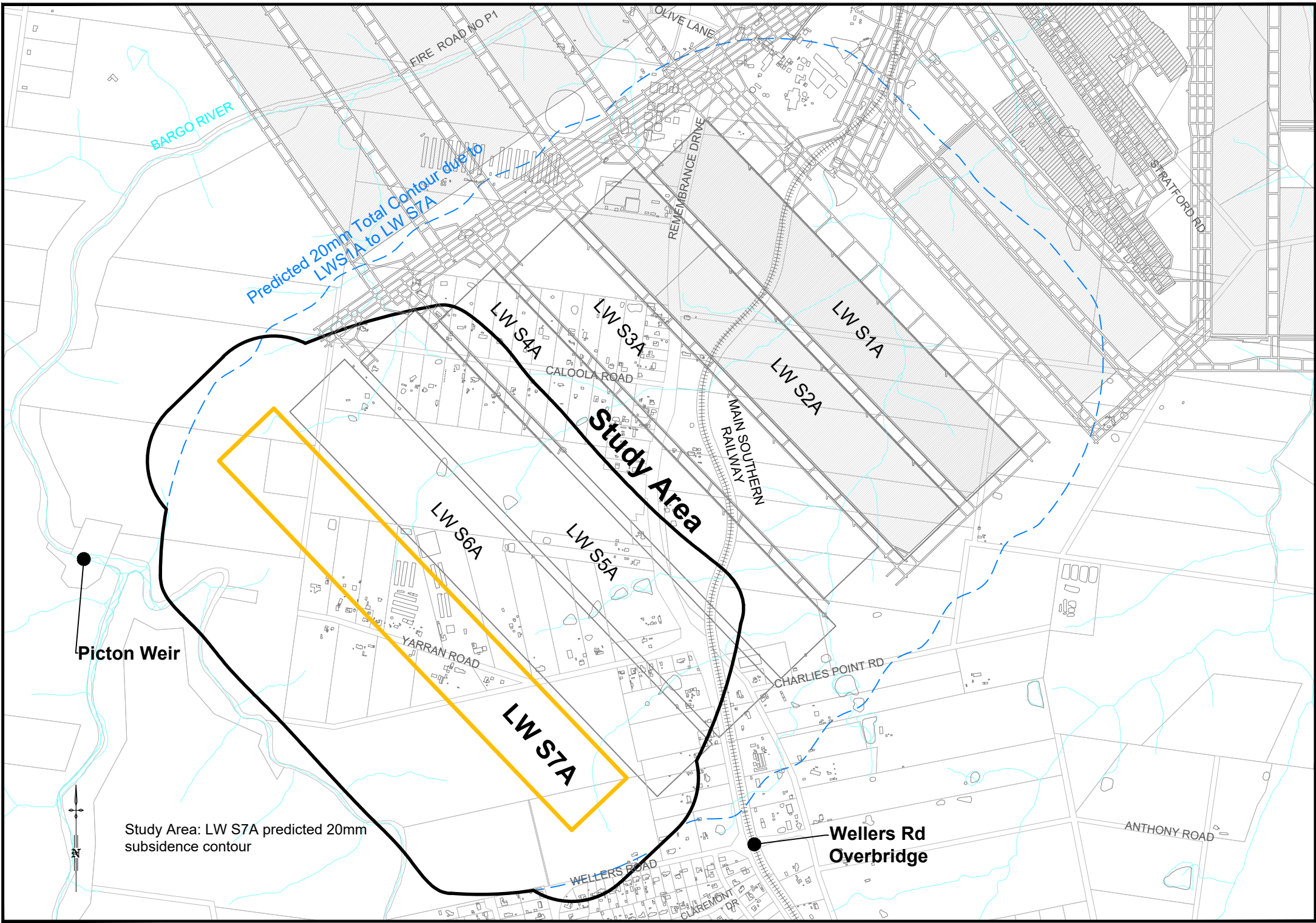

Creek Remediation Works Overview: <ul style="list-style-type: none">Myrtle Creek remediation schedule completed in August 2022.Redbank Creek schedule completed in November 2024.Both creeks are in monitoring phase for at least 24 months post completion of the remediation works – Monitoring includes surface water level, groundwater levels and aquatic ecology.Spring aquatic ecology results are being processed – to be reported next TCCCC meeting.Tahmoor advised the Resources Regulator of the completion of the Corrective Management Action Plan in February 2025.<ul style="list-style-type: none">DH asked will there be a final CMAP completion document detailing the whole project and outcomes and if so, can this be distributed to the committee?
